Mr. Williams and Mrs. Stedman said thank you for creating the documentation.

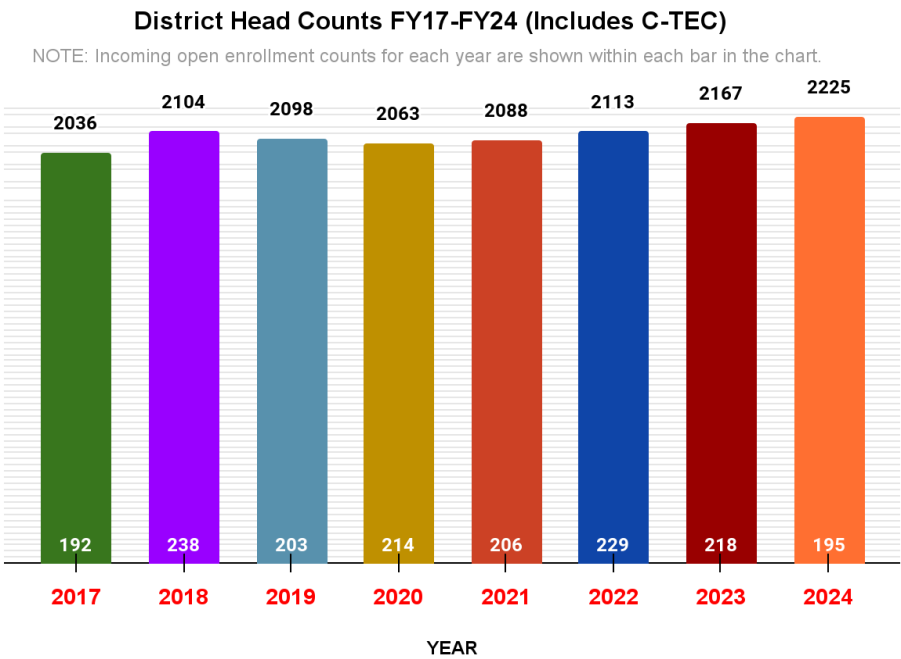

Board Policy: 4417.01 - Bullying and Other Forms of Aggressive Behavior

Any intentional written, verbal, electronic, or physical act that a student or group of students exhibits toward another particular student(s) more than once and the behavior both causes mental or physical harm to the other student(s) and is sufficiently severe, persistent, or pervasive that it creates an intimidating, threatening, or abusive educational environment for the other student(s); or violence within a dating relationship.

"Electronic act" means an act committed through the use of a cellular telephone, computer, pager, personal communication device, or other electronic communication device.

Aggressive behavior is defined as inappropriate conduct that is repeated enough, or serious enough, to negatively impact a student's educational, physical, or emotional well-being.

PUBLIC COMMENT (Non-agenda items)

Ms. Mary Kay Martin thanked Mrs. Christian for her years of service.

Following the discussion at the November meeting, Ms. Martin said that two principles of human development came to mind; Erikson's trust vs. mistrust and need vs. want.

She also spoke about public vs. private and the ongoing tug between those educational options.

Ms. Martin said she would like to thank Mrs. Stedman for seeking additional knowledge in regards to curriculum development finding that our surrounding school districts approach this process similarly and differently. Ms. Martin noted that nowhere were school board members the sole creators of curriculum. Public schools must abide by state standards and how each district constructs the curriculum in order to teach the standards is left to each district, providing local control. She said she felt public schools in Licking County seek to hire competent administrators and educators to apply appropriate teaching methodologies to support students in meeting their age appropriate learning goals. The board trusts that process and approves it during regular public board meetings.

She said a healthy relationship between school board members and school employees is based on trust. You trust the people you hire to administer the district and then approve their curriculum decisions. This is different than making unilateral decisions that supersede sound educational practices.

Ms. Martin said that as far as appropriate reading material, the same principle applies and librarians and educators are hired to make thoughtful and pertinent decisions on materials that reach out to the interests of all students. The board already had a policy in place if parents felt a particular book or classroom assignment did not meet with their approval. Ms. Martin said she thinks it is telling when the process for checking out a book was modified to allow parents to opt out, 2/3 of the student body had parents who trusted their child to make his/her own decision.

Ms. Martin addressed Mr. Williams and said that it makes sense to align the digital word policies with the written word policies as students toggle back and forth between these two mediums. She said she has concern with cherry picking books because they are on someone's list of books to ban. She stated that one must look at the total work rather than take certain passages out of context. A child needs to learn the true history of our country, ignorance is not bliss since we

often repeat the same behaviors over and over again. We are all human beings regardless of our differences.

Ms. Martin turned her focus to “need vs. want”. She said, we all need our children to have access to a high quality, 21st century, well-funded education which allows them the opportunity to develop the skill sets necessary to engage in society and provide for their future needs. We need our children to live within a community that supports kindness, caring and love, not hate and vengeance.

She stated that, as parents, we all want to control the world around our children. It is our #1 goal to keep our children safe. So we also want to control our child’s educational experience.

She said that the needs are met by vibrant diverse community and a well-funded public school system. The wants are met by having your child attend a private school or home school.

Mr. Gordon Postle thanked Mrs. Christian for her service. He also thanked Mr. Beery for a guided tour of the art at the middle school. Mr. Postle asked Mr. Douglass how much money goes with students for vouchers and if it was around \$8,000. Mr. Douglass said it was a little over \$8,000. Mr. Postle asked who has to go through background checks and if board members have to have background checks. Mrs. Christian said board members are not required to have a background check. Mr. Beery provided details about who is required to go through background checks.

Mrs. Lucinda Wills thanked Mrs. Christian for her years of service. Mrs. Wills said she appreciates Ms. Martin’s words that she provided. She explained some information that she had received about banning books. Mrs. Wills said maybe we should talk to the kids to see what they need.

Mr. Bill Weaver thanked the district for partnering with the Licking Valley Heritage Society. Mr. Weaver told the board about an upcoming event with the Licking Valley Heritage Society and invited everyone to attend.

BOARD DISCUSSION

Mrs. Stedman asked Mr. Beery about a community development committee and if we have heard anything about it. Mr. Beery said he would love to have a conversation with the individual if Mrs. Stedman wanted to provide the contact information to reach out.

Mrs. Stedman said she thought that we should hold off on any committees until after we work through strategic planning goals and that it would be premature to do it before finishing the strategic planning process. Mrs. Stedman said she sent the additional examples of library policies that were discussed in the previous meeting and that she thought policies is the one area where a committee could definitely be formed. Mrs. Stedman said she is not in a rush and all this could also wait until January. Mrs. Kollar said she agreed with the committees and waiting for the strategic planning objectives.

Mrs. Kollar thanked Mrs. Christian for all of the help she provided her and thanked her for everything she has done for the district and that her children are a product of this district.

Mrs. Stedman thanked Mrs. Christian for everything she has helped with and said she will be missed.

Mr. Williams agreed with Mrs. Kollar. He thanked every board member, superintendent and treasurer, both current and previous, for their service. Mr. Williams said Mrs. Christian led during a difficult time and did it with grace and confidence. Mr. Williams said his kids have benefited from being part of this district.

Mrs. Torbert said she and Mrs. Christian have gone through tough times together and appreciates Mrs. Christian’s leadership and thanked her for everything.

Mrs. Christian said it has been a pleasure and privilege to serve the Licking Valley School District. She thanked the voters and acknowledged the community for their interest in the district. Mrs. Christian thanked current and past board members. She thanked the employees of the district. Mrs. Christian thanked the teachers and paraprofessionals for all they do to make the district better for the kids. She thanked the leadership team. Mrs. Christian thanked the community members for their involvement and welcomed Mr. McArtor to the board.
