2018 Leaders for Learning Award

Congratulations to Patty Ellick on Friday October 12th Patty received the 2018 Leader for Learning Award. The following is the Letter that Mrs. Crum wrote.

I nominate Patricia Ellick for the Leaders in Learning Award for her exemplary work in the field of technology. Patty has 35 years of teaching experience, with the past 14 years being in the Licking Valley School District.

Patty does an incredible job teaching Computer Integration classes to approximately 950 K-5 students. Not only does she focus on basic computer and keyboarding skills, but her primary focus is on using the computer technology as a tool for learning.

Her carefully designed lessons demonstrate collaboration with grade level teachers which enables her to design integrated content area lessons while teaching new technology skills. Her goal is to reinforce the curriculum being taught in each grade level through technology rather than a focus on the technology programs. This integrated approach focuses on real world application. Additionally, she focuses on computer etiquette and safety, as well as reliable internet sources.

Patty also does a commendable job reaching out to parent volunteers to assist with her younger students. She has a steady stream of volunteers who come to the school regularly to work in the computer classes. When faced with the challenge of working with the younger "click happy" students with mixed experiences in the area of technology, she found an effective and practical way to meet their needs.

As if teaching 950 students integrated computer lessons is not enough, Patty also creates the intermediate yearbook, assists with Youth to Youth and works as the Building Technology Coordinator. She puts in many hours to set up, tear down and troubleshoot the computer needs of both Licking Valley Primary and Intermediate Schools. She always approaches her work with a willingness to help others and a can do attitude.

Patty also develops strong relationships with students regarding their outside interests and activities. She attended many dance recitals, plays, games and competitions for her students. She also attends monthly Panther Parent Skate Night events and spends the whole time out on the floor teaching students how to skate. When serving 950 students that cannot be an easy task.

Patty's dedication to teaching and learning, as well as her passion for helping students learn and grow in the area of technology, make her an excellent candidate for the Leaders for Learning Award.



STEP Program Experiences

Three Licking Valley Staff members participated in the Summer Teacher Experience Program this summer. Shane Hancock, Deana Bennett, and Becky Lawrence were mentored in the workplace while working with different positions, skill sets, and work environments.

Shane spent one day at Boeing and gained tremendous insights into various possible career paths for Licking Valley students. The tour of the facility, hosted by Daryl Dickerson and several other engineers and department leaders, displayed the many possibilities for students after they leave high school. On the one hand, students who decide to continue their education in engineering certainly can find a rewarding career path in a company like Boeing. The atmosphere was exciting, the workload was meaningful (as it is important to national security), and the staff spoke about their jobs with enthusiasm and satisfaction. On the other hand, an engineering degree is not necessarily needed to land a job at Boeing. In fact, once someone's foot is in the door as a technician, for example, the company will fully fund their education in a science-related field. Many of the staff mentioned they were working on their degrees online or in evening classes. Other jobs, like welders and shop related jobs, were also needed in the facility. Boeing is active in reaching out to students in the local community as well. They have hosted programs and tours for students across the county to engage and excite students towards a STEM career. In fact, they recently hosted an entire class of seventh grade girls. The Boeing tour was very eye-opening, demonstrating the various possibilities for career paths after high school.

Deana and Becky spent three days at Family Jobs and Services. Under the direction of Nathan Keirns, they gained knowledge of services provided for our community. The wealth of resources strengthens the programs already available at Licking Valley LSD. Collaboration with specific individuals to address student and family needs such as Mental Health Awareness will be a great asset in the future.







Licking Memorial Dental Clinic for Children

The Program

In partnership with the Licking County Foundation, Licking Memorial Hospital (LMH) offers a dental clinic to serve uninsured, low-income children in Licking County. The Licking Memorial Dental Clinic for Children is set up in the dental practice of Keith A. Wing, Matthew P. Mack, Christopher P. Smith and Robert L. Bang, D.D.S., located at 1420 Dickerson Street in Newark. The Licking County Foundation has contributed toward the costs of services, supplies and office space.

Who Is Eligible?

- Uninsured children who are eligible shall meet the guidelines outlined in the Licking Memorial Dental Clinic for Children application (attached).
- Children who are covered by an Ohio Medicaid Managed Care Plan are automatically eligible, and completion of the application is not necessary. Call (740) 344-7853 to schedule an appointment.

How to Apply for Assistance

- Complete the application.
- Submit the application to the dentist's office.
- The office will contact the patient and schedule an appointment, if eligible.

If you have any questions or need assistance in completing the application, please call the Licking Memorial Dental Clinic for Children at (740) 344-7853.

Income:

You must provide the amount of your family's total gross income for the three months or twelve months immediately prior to the date(s)-of-service for which you are requesting assistance. This must include income for all members of the immediate family living in the household. You must write the total gross income in the space provided on the application. Additional

documentation of income is not required to be returned with the application. However, you are responsible to maintain supporting documentation of the income reported. In the event of an audit, you will be required to produce acceptable documentation.

Examples of acceptable income verification include:

- Check stubs for the three months or twelve months prior to the date-of-service.
- Documentation of Social Security, unemployment compensation, alimony, child support or pensions. If you do not have documentation to support these income sources, you should contact the issuing office to request a statement of income for the appropriate time period. If an employer's statement of gross income is used, it must be signed and dated by the employer and must be printed on company letterhead. Self-employed applicants must provide gross income, less reasonable business expenses. Personal expenses are not permitted. In the event of an audit, acceptable income verification includes Tax Schedule C.
- If you earned \$0 income for the three months or twelve months prior to the date(s)-of-service, provide a brief explanation on the back of the application or on an attached sheet. Your explanation must include the beginning and ending dates of the period in which your family earned \$0 income (3 or 12 months prior to the services for which you are applying for assistance).

Family:

For the Dental Clinic Program, "family" is defined as the patient, patient's parents and patient's siblings (under the age of 18, natural or adoptive) living in the patient's home.

To be eligible for the Dental Clinic Program:

- You must be a Licking County resident.
- Your household income must not exceed 250% of the federal poverty income guidelines.
- Patient must be under the age of 18.
- Cannot be eligible for Medicaid or covered by dental insurance.
- Patients covered by an Ohio Medicaid/Managed Care Plan are automatically eligible.


