

STUDENT ATHLETES

Board Policy #2431

The district would like to remind parents and student athletes that according to Board Policy #2431 students need to achieve a 1.66 GPA in the 4th academic quarter of each school year in order to be eligible for fall sports the following school year. High School students must also have completed 2.5 credits in addition to the 1.66 GPA.

The Title I Reading Program at Licking Valley

Title I is a Federal Aid program through which most Ohio School districts receive funding each year to provide supplemental instruction for those students who qualify. To receive these funds, each state must submit a plan describing:

- What children are expected to know and be able to do;
- The high-quality standards of performance that all children are expected to meet;
- An ongoing record of student progress through assessment.

The Title I funded schools must work to:

- Identify students who are failing, or most-at-risk of failing, to meet state standards in reading or math
- · Focus instruction to meet the specific needs of each child
- Develop programs that add to regular classroom instruction
- Involve parents in all aspects of the program.

Our Title I targeted assistance Reading Program provides intensive instruction to help our low-achieving children in grades K-5 master challenging curricula and meet state standards in reading. Our Title I teachers work closely with their students' regular classroom teachers in designing their extra instruction.

Search for Children with Disabilities

School districts throughout Ohio actively participate in an effort to identify, locate and evaluate all children with disabilities birth through age 21. - For the start of 2016-2017 school year the state of Ohio is requiring the Tdap and Meningococcal vaccines for 7th grade student attendance to public schools.
- Exceptions must be filed with school prior to the start of school year.
- Contact your family doctor to see if your child may need these vaccines.

If you are interested in taking classes that are not available in the traditional high school setting, then you will be interested in an exciting opportunity at Licking Valley Local Schools.

The classes are offered through ACE Digital Academy and can be taken online while at home or during the school day at Licking Valley High School with a Licking Valley teacher to monitor your progress and assist



with any questions you may have about your lessons. We are also offering online classes to students who did not finish credits to earn a high school diploma. Over 250 classes are available such as Accounting, Archeology, Astronomy, Business, Criminal Justice, Foreign Languages (Spanish, French, German, Japanese, Mandarin Chinese, Latin), Nursing, Vet Science, STEM classes and IT classes.

While in the Educational Options Program you remain a Licking Valley Student and can participate in extracurricular activities such as clubs and athletics as long as you meet the requirements set by LVLS and OHSAA. You are able to ride the bus to and from school if you are in the district. You can also receive scheduling assistance and guidance support from school guidance

counselors. When you graduate, you will receive a Licking Valley High School Diploma.

The Licking Valley Schools Transportation Department handles daily transportation to and from school each day for an average of 1365 students.

- The fleet consists of 24 buses and one school van. 4 of these buses are spares. The oldest bus was purchased in 2001, and our newest bus was purchased in 2015. The bus with the most miles currently has 200,393 miles on it.
- The district has a total of 20 bus routes each day: consisting of 18 high school, middle school, and elementary and 2 handicapped, special education and preschool. The district also runs a school van as a special education route.
 The bus fleet runs an average of 2031 miles per day, for an annual average of 353,394 miles. The school van runs 200 miles per day.
- During the 2015-2016 school year the fleet also ran trips totaling 24,386 miles for the following purposes.

Licking Valley Local Schools Are Tobacco Free

ATTENTION PARENTS!!! CONTACT INFORMATION UPDATES ARE IMPORTANT!

As you know, our school secretaries keep contact information on file for all of our students, including home phone, cell phone, and email data for all emergency contacts for each student. It is critical that parents make a special effort to notify your child's school promptly when any contact information for your student



changes. The contact information on file is used not only by your child's school, but also by our transportation department in the event that a bus situation requires us to contact you. Also, our **Leader Alert** instant messaging system uses contact information for any recorded messages sent by the district, such as snow day notifications. We also use email address information for distribution of parent email messages during the school year. It is vital that all these departments have the most current information on file so that we can contact you if the need arises. So, please make sure to call the secretary at your child's school and update them on any phone number or

email address changes. Should you have students at more than one building please contact each school to make sure they have the updated information as well. We can only keep our records current based on what our parents provide, and we appreciate your help in making sure your information is up-to-date.

Dear parents and athletes,

We are excited to announce the roll out of our new online pre-participation paperwork system. Below you will find the instructions on how to go about setting up an account and how to finish the necessary forms.

Prior to participating on a team with Licking Valley Schools, athletes and parents must provide the Athletic Department with current address, emergency contacts, insurance, medical alerts we need to be aware of, and health history information. I know a lot of this is covered on physical forms, but just like with the PrivIt forms, once this information is completed, it will automatically save each year and you will only be required to update any changes you have. It will save time in the long run. In order for us to be thorough with the collection of this information, we have chosen to utilize **Sports Ware Online**.

To enter your information for your athlete, please go to <u>www.swol123.net</u>. The first time you visit the website, you will need to scroll to the middle of the screen and click the Join **SportsWare button.** You will then enter the school's ID, which is LVPanthers1. Enter the athlete's first and last name, email address, and click send. This request will then be sent to me. I will be checking the website frequently every day, so be patient, you will likely receive your email saying your request was accepted. Open that email and click on the link back to <u>www.swol123.net</u> to continue setup. You will enter your email address on that first page and click reset password. Set a password you will remember or write it down for future log ins. From there, there are three categories you will need to fill out information under: My Info, Med History, and Forms. Fill out all required fields before you log out. If you choose to print your information for your own records you can, but the information will be saved as you enter it, so printing is not necessary.

<u>Please complete all information before the first official day of practice for your particu-</u> lar season in order to avoid your athlete being held from activity.

Megan Scott, MS, LAT, ATC Licking Valley Athletic Trainer he Licking Valley School District has partnered with All Star Driver Education to offer our students an online driver education program that they can complete at their own pace and on their own time at a reduced price as compared to local options. The online driver education course costs \$79.00, and the required eight (8)



hours of in-car driving instruction will cost \$329.00. The combined cost is a savings of approximately \$60 over other local options. Students will also be eligible to receive one-half of an elective academic credit for completion of the program, including the driving portion. To receive credit students simply have to complete both the online instruction modules and the eight hours of driving instruction and bring their certificate of completion to their guidance counselor.

The in-car driving instructors are local citizens who we know and who are licensed in the state of Ohio to provide driving instruction, and who will have regular criminal background checks to ensure the safety of our students.

If you have a busy teenager who doesn't have time to get to and sit through in-class driver education courses, this is an excellent option for you, especially when your student has their own personal computer. If you are interested in pursuing this option simply go to this website https://www.allstardriveredonline.com/register.php?id=24 and create an account, and when your student is ready to do the in-car driving instruction just have him or her contact Jane McKee at the district office, 763-3525.



To date, 70 of our students are either enrolled in the online course or have completed it. All Star wants to offer our students the 8 hour driving instruction with a certified driving instructor as well but they need certified driving instructors in our area to do the drives with our students. Below is all of the information about becoming a certified driving instructor. All Star pays instructors \$15.00 an hour, and each student needs 8 hours of driving instruction. 



Friday, August 5, 2016 thru Sunday, August 7, 2016

S.B. 264 enacted a sales tax holiday to occur only in 2016. The holiday starts on Friday, August 5, 2016 at 12:00 a.m. and ends on Sunday, August 7, 2016 at 11:59 p.m. During the holiday, the following items are exempt from sales and use tax:

- Clothing priced at \$75 per item or less;
- School supplies priced at \$20 per item or less; and
- School instructional material priced at \$20 per item or less.

Items used in a trade or business are not exempt under the sales tax holiday.

FAQ

1. When is this tax-free weekend and how long does it last?

A. The holiday is one-time event that begins Friday, August 5, 2016 at 12:01 a.m. and ends on Sunday, August 7, 2016 at 11:59 p.m.

2. What stores are participating in the tax-free weekend?

A. All retailers in the state that sell items that are exempt from sales tax (see qualifications listed above). The holiday is state law and retailers must comply.

3. What is NOT defined as clothing by the exemption?

- Items purchased for use in a trade or business.
- Clothing accessories or equipment.
- Protective equipment.
- Sewing equipment and supplies.
- Sports or recreational equipment.
- Belt buckles sold separately.
- Costume masks sold separately.
- Patches and emblems sold separately.

4. Does the exemption apply to shipping and handling charges?

A. Yes, items can be bought online. If all items in a shipment qualify as eligible items and the sales price for each is within the sales tax holiday price threshold, the shipping and handling charges are <u>not</u> taxable.
