The clinic is a combination of many good things and volunteers (both professional and nonprofessional) who are very generous with their time.

The clinic provides an opportunity for you and your child to meet many of the school personnel including: school nurse, physical education teacher, kindergarten teacher, speech pathologist, aides, secretary, transportation personnel, and many volunteers who live within the school district.

There will be registration forms for you to complete. A baby book or record may help you remember necessary information. You and your child will then be directed to the following areas: vision & optometric, physical examination, speech/language screening, motor development, dental, hearing, readiness screening, fingerprinting, and photo identification will also be offered.

You will also meet your child's teacher and a representative from the bus garage will let you know what bus your child will ride to school. At the conclusion of the clinic, your child's immunization record will be checked and you will be advised of any necessary updating to comply with state law.

The clinic takes approximately two hours to complete and the information obtained and the screenings given are invaluable.

#### Please bring the following to the clinic with you:

Child's immunization records, baby book or record for ages walking, sitting, "potty" training, etc.; birth certificate or proof of age, social security card and custody/guardianship papers if applicable. Also, please have your child wear tennis shoes or other comfortable shoes as he/she will be asked to do some physical activity.

#### You may register your child anytime prior to April 16<sup>th</sup>.

#### **OPEN ENROLLMENT - GOOD OR BAD?**

I recently received a letter from one of our district residents questioning why the Licking Valley Schools accept students on open enrollment from other districts, which provides me with an excellent opportunity to share some information about this important, but sometimes misunderstood topic. The individual's concern was that our district incurs the costs of educating the open enrollment students, but the students' parents do not pay the 1% district income tax or the local property taxes because they do not reside in the Licking Valley District.

Licking Valley School Board Policy 5113 - Inter-District Open Enrollment, states, in part:

The Board of Education shall permit the enrollment of students from any Ohio district in a school or program of this District, providing each enrollment is in accordance with laws and regulations of the State concerning Inter-District Open Enrollment, the provisions of this policy, and the administrative guidelines established to implement this policy.

Currently, we have 63 students coming to LV on open enrollment from other districts, and we have 25 students leaving on open enrollment to other districts. Students who come to us on open enrollment bring with them their Ohio Foundation Funding which is the per pupil amount of money their home district would receive from the state to educate each child, and they also bring with them the per pupil share of the local tax dollars (or district tuition rate) generated in their home district.

The 63 students who are coming to LV this year on open enrollment brought a total of \$354,703.65 with them. The 25 LV student who left on open enrollment to other districts took with them \$139,158.70. That leaves LV with a net gain on open enrollment of \$215,544.95.

If the Licking Valley Local Schools did not offer open enrollment and accept open enrollment students, it is logical to assume that we would still have 25 students leaving on open enrollment, and the district would have a net loss of \$139,158.70. It disappoints us that even one of our residents would feel that LV is not the best place for their child to be educated because we believe that LV is the best school district in Licking County, and we have tried various measures in the past several years to decrease that number and retain every child in our district. We will continue to identify and monitor the circumstances which lead some of our residents to seek educational opportunities outside of the Valley, but at the same time, we believe it is a very positive statement about our district that the parents of 63 students from outside of the Valley see Licking Valley Local Schools as the best educational option for their children. It should also be noted here that another 39 students submitted applications to come to LV on open enrollment for the 2007-2008 school year and their applications were denied for various reasons, primarily because of class size restrictions. Were we in a position to accept all applicants, we would have nearly four times as many students coming in to our district on open enrollment as we have leaving.

#### **TESTING SEASON**

Testing season is now upon us. The months of March, April and May bring the OGTs to the high school and the OATs to the intermediate and middle schools. Our staffulty has been working hard with all of our students since August to ensure they each acquire the knowledge and skills necessary to be successful on these important measures of student achievement. Despite all of this preparation, testing, especially formalized testing such as these mandatory state assessments, some of which are high stakes in nature, can produce a lot of anxiety for students. Staffulty members will do some things to help reduce students' anxieties, such as making sure they have mastered the concepts that will be assessed and giving them a lot of exposure to the types of items they should see on the assessments. They will also teach them a number of useful test-taking strategies. In addition, the testing days in our schools will be structured in such a way as to produce the optimal environment for success.

There are also a number of things parents can do to reduce their student's test anxieties and ensure that they are well prepared for success on test days.

## **STUDY ISLAND**

Studylsland.com – All Licking Valley students in grades 3-12 have a username and password for Studylsland.com. This is a web-based program that is deeply aligned to Ohio's Academic Content Standards for reading, math, science and social studies, and provides practice test items that are just like OAT and OGT test items that have been on previously administered assessments. Students who have access to the internet at home or at the library can do as much practice on these test items as they are willing to do, and they should, especially in areas where they may have struggled in the past. If you need your student's username and password, check with your child, or contact his/her teacher.

BREAKFAST - Research tells us that students who eat breakfast perform better on tests than students who don't eat breakfast. Our schools will offer breakfast foods of some kind during the testing weeks, but if your child is one who doesn't usually eat breakfast at school, please make sure they have breakfast before they leave home. Bananas are considered the new 'brain' and 'energy' food, so if nothing else, make'em eat a banana!

**SLEEP** - None of us need any research to know that we tend to perform at much higher levels when we are well rested versus times when we have not gotten enough sleep. Testing week is physically and mentally exhausting for our students, especially when they have multiple tests in the same week. Parents should make sure their students are always getting proper amounts of sleep, but during testing week we should all be a little more vigilant in making sure elementary students get at least 8 to 9 hours of sleep, and high school and middle school students get a minimum of 7 or 8 hours of sleep each night.

These may seem like little things, and they are, but it is the little things that may get your student over the proficiency hurdle on the state assessments.

#### **ACHIEVEMENT TESTS**

The mission of public education has changed. Demonstrated learning, not just school attendance is now demanded of all public schools. During the months of March and April students will be able to

demonstrate their learning on Ohio's Achievement Tests in grades 3, 4, 5, 6, 7 and 8. Ohio Graduation Tests for grades 10 and 11 will complete test requirements for graduation. These tests are all part of Ohio's accountability system.

Achievement Tests – Required assessments that measure students on what they know and are able to do in mathematics, reading, science, social studies and writing, with administration to students spread out from third to eighth grade (replace Ohio's proficiency tests).

Ohio Graduation Tests (OGT)-Assessments aligned to Ohio's Academic Content Standards in reading, mathematics, science, social studies and writ-

ing that students in high school must take to demonstrate proficiency before graduation from high school.

Alternate Assessments-A non-test method that documents access to grade-level content standards by students with significant cognitive disabilities at an alternate standard of achievement.

**Diagnostic Assessments-**Tools that assess student strengths and weaknesses to inform instructional decisions.
