

The 2012 Licking Valley Marching Band season has been one for the record books. This year they competed in 4 local OMEA (Ohio Music Education Association) sanctioned events and they qualified for OMEA State Marching Band Finals at 3 of the four events. At the Cambridge Cavalcade of Bands on September 15th, the band won first place and best percussion in class B. They followed that up with a second place finish, best percussion, best auxiliary, and their first superior rating that qualified them for state at the Zanesville Bonanza of Bands on September 29th. The Marching Panthers continued their successful season by earning another superior rating at their own band contest at Licking Valley High School on October 6<sup>th</sup>. Their final local performance was this past Saturday, October 20th, at the Tri-Valley Classic where the band earned the Grand Champion award for class B/C and another superior rating from the judges.

The band's 2012 competition show is entitled "Home of the Brave" and it features songs that recognize the history and sacrifice of the brave men and women who have and who continue to defend the freedoms of our

## Gifted Screenings

The Gifted Department of Licking County Educational Service Center will be conducting screening for gifted identification in the visual and performing arts, specifically in the areas of painting, sculpting, drawing, vocal music, instrumental music, dance, or drama. According to Ohio law and district policy, students in grades Kindergarten through grade 12 may be nominated for assessment for gifted identification. Between the months of November and February, nominated students will be evaluated using a checklist of gifted behaviors and, for those who earn a qualifying score on the checklist, a demonstration of the student talent in the fine arts. Parents, teachers, or students may nominate possible candidates for evaluation. Nominations must be received in the Licking County ESC office no later than November 2, 2012. Additional information will be sent to parents of nominated students in mid November. ## **EZpay**

In an attempt to provide parents with the opportunity to make school fee payments on-line, a decision was made at the end of the 2011-12 school year to change over to EZ-Pay from NutriKids. EZ-Pay provides parents with the opportunity to make multiple type school payments on-line. NutriKids processes meal payment only. Because we didn't want parents to have to pay multiple transaction fees, this seemed like the most viable solution. Parents can register their student(s) with EZ-Pay and do the following:


#### Why Ohio's 3<sup>rd</sup> Grade Reading Guarantee May Guarantee Student Failure

The following is an excerpt from a revision to Ohio Revised Code 3313.608 that went into effect in September 2012:

"Beginning with students who enter third grade in the 2013-2014 school year, no school district shall promote to fourth grade any student who attains a score in the range designated under division (A)(3) of section 3301.0710 of the Revised Code on the assessment prescribed under that section [i.e., the 3<sup>rd</sup> Grade Reading OAA] to measure skill in English language arts expected at the end of third grade . . ."

With this change to the law, your Ohio legislators and Governor Kasich have seen fit to ignore all of the existing research on student retention, and institutionalize through legislation, retention for 3<sup>rd</sup> graders across the state of Ohio based on one test score on a standardized test taken at the end of the 3<sup>rd</sup> grade year, irrespective of what the student's parents, teachers, counselors and principals know about the student, his educational background, his progress over the past four years of his education and all other possible variables.

Why is this an outrageous and indefensible decision by the politicians in Columbus? Let's consider an analysis of all the valid and reliable research that has ever been done on student retention. Educational researcher and author, John Hattie, conducted a meta-analysis (research of the research) of 800 meta-analyses, published in 2009 under the title *Visible Learning*, on an exhaustive list of factors impacting student achievement, one of those factors was retention. Below is a diagram of the measurement graphic Hattie constructed to illustrate the impact of each factor on student achievement relative to 0.0 on a standard deviation scale and his "hinge point", which is +.40 of 1 standard deviation. If a student achievement factor rates a 0.0, it has no noticeable impact on student achievement, if it rates a +.40 or higher it has a meaningful impact on student achievement, if a factor rates below 0.0, it has negative impact on student achievement.



Retention rates a -0.16! As you can see on the diagram, it rates as having "Reverse Effects"! Also, note in the key to the right of the diagram the exhaustive nature of Hattie's research. -0.16 for retention's impact on student achievement is the average effect size (i.e., the measurement of a variable's effect on an outcome) calculated from the analysis of 7 meta-analyses, 207 separate studies generating 2,675 effects and involving almost 14,000 students. In other words, our politicians who supported and implemented this change in the law would have to do their own research studies to even attempt to challenge this research, which, again, is an analysis of all of the valid and reliable research that has ever been done on the subject of retention. Here is how Hattie sums up his findings:

"[Retention] is one of the few areas in education where it is difficult to find any studies with a positive effect, and the few that do exist hover near zero. . . . Retention has been found to have a negative effect on academic achievement in language arts, reading, mathematics, work-study skills, social studies and grade point average. . . . Moreover, being retained one year almost doubled a student's likelihood of dropping out, while failing twice almost guaranteed it. . . Holmes (1989) concluded that it would be difficult to find another educational practice on which the evidence is so unequivocally negative." (Hattie, 2009)

If retention is so negative for student achievement, why, you might ask, does the Licking Valley Schools still retain students? Good question. The difference is that when we make a decision to retain a student it is done with a vast and comprehensive knowledge of the student and what that student needs to be successful academically. That decision is also made with the input of the student's parents, teachers, teachers' aides, principals, guidance counselor and anyone else who may provide important input to ensure that the decision is in the very best interest of the student. Assessment data will be factored into the equation, but it certainly will not be the sole determinant for retention.

The politicians in Columbus constantly admonish educators to use research-based best practices in educating Ohio's children, yet they frequently not only ignore the research but often create legislation that forces us to do exactly what the research tells us we should not do, and often flies in the face of common sense. Under this new law, all Boards of Education in the state of Ohio are required to adopt a 3rd Grade Guarantee policy that follows exactly the dictates of ORC 3313.608 and thus retain students in 3<sup>rd</sup> grade if they fail to achieve a score of 390 or higher on the 3<sup>rd</sup> Grade Reading OAA. A review of the current Licking Valley 4<sup>th</sup> graders who took the 3<sup>rd</sup> Grade OAA last spring reveals that we had 13 students who scored below the 390 cut score requiring retention of those students. All of those students were identified in their primary school years (K-2) as struggling readers and all had received intensive reading intervention services in an effort to get them to grade level as soon as possible (one of our goals is to get at least 90% of 2<sup>nd</sup> graders reading on grade level by the end of second grade). Why 90% and not 100%? Five percent of those students have recognized learning disabilities which prevent them from achieving grade level proficiency at the same rate as their peers, but we never quit striving to get them to grade level, and the other 5% do not have a learning disability, but came to us several years behind their peers in literacy skills and we have not had the time to catch them up by the end of 2nd grade, but again, we never stop working to get them reading on grade level.

The fact is, retention is not the solution to students reading below grade level. The solution is effective instruction, frequent assessment, the use of assessment data to guide instruction, identification of students who are not achieving or growing, communication about that issue between the teacher and the parent and development and implementation of appropriate and effective reading intervention services with the goal of getting the student reading on grade level as quickly as possible. The Licking Valley Schools has a process in place to do this effectively and we are happy to share that process with anyone who cares to know more, including the politicians.

If you believe that the 3<sup>rd</sup> Grade Guarantee, which guarantees that we retain 3<sup>rd</sup> graders if they fail one assessment on one day in 3<sup>rd</sup> grade, requires more informed consideration by our politicians, please make an effort to share your thoughts with them.

# FFA Soil Teams Place in District and State Meets

The LV FFA soils teams competed in the District 7 soils contest ed by the Pickaway County Soil District. District 7 consists of school

and Water Conservation from Knox, Licking, Franklin, Fairfield, Pickaway and Ross counties. Students on the judging team must identify slope, erosion of topsoil, soil texture, bedrock restrictions and air and water movement to determine the optimum conservation practices needed for a particular site. The Rural team, which judges soils for their agricultural use, placed 3rd in the district. The team members placed well as individuals with Josh Ellis placing 1st overall. Other rural team members were Spencer Bell, Charlie Burwell, Ronnie Richardson and Trent McArtor. The Urban team, which judges soils for housing development, placed 5th. Ryan Vlachos was the team leader placing 11th other members were Cara Dillon, Ashley Dillon, Sarah Gearhart and Hanna Gearhart. The teams qualified for State competition October 13 at Malabar Farms with the top 50 teams from Ohio competing for a chance of advancing to national competition in Oklahoma. The Rural Team placed 4th overall at state competition with Josh Ellis placing 7th in the state in a field of 185 students. The top 3 teams advance to nationals and LV missed advancing by 2 points out of a possible 1836 points. Members were awarded for their efforts at the Licking County Soil and Water annual meeting.
