Cafeteria News By Jan Jennings, Cafeteria Supervisor

As we continue to settle into the new elementary facility, I would like to take the opportunity to explain some of the exciting new changes that are taking place in the cafeteria. All of our students K-5 will be on the NutraKids point of sale system. This state-of-

the-art tracking system allows us to monitor our student meals, keep track of student account balances, and confidentially track free and reduced students in addition to a long list of additional month end reporting features.

We are also in the process of working out the details of how to successfully continue the breakfast program in the new facility so students who wish may participate in the program with minimal class disruption.

The Lunch program will remain the same for grades K-2. We will continue to follow the same menu and offer the sack lunch option. The kindergarten and first grade teachers will be sending tongue depressors with the student's ID # and money (sent to school with students in the morning) to the cafeteria and their information will be entered by our cashiers into the NutraKids system first thing in the morning. Parents of kindergarten and first grade students have the option of prepaying their student's accounts too. The second grade students have done a trial day entering their own ID numbers into the NutraKids system and will be entering their own ID numbers and bringing their

own money to the cashiers. Again, parents have the option of prepaying their student's account. (Parents: please do not worry, these student's are doing a great *job with this and I* would guess that about 90% of them already know their ID number and will be using that same number when getting on to Study Island and for many other things as they progress through the Licking Valley

For students in grades 3, 4, and 5, the cafeteria menu will remain the same and they will continue to offer the sack lunch option, but we will offer some additional items for your student to choose from. I have listed a sample of the additional items:

 Cut fresh fruit (i.e.: orange wedges, apple slices w/ caramel, and additional in-season fresh fruit) at an additional cost of \$.50.

- Cut fresh vegetables (i.e.: celery w/peanut butter, carrots w/ranch dip) at an additional cost of \$.50.
- Baked Snack Chips at an additional cost of \$.50
- Otis Spunkmeyer cookies at an additional cost of \$.35
- 100% Juicy Juice Carton at an additional cost of \$.40
- 12 oz. Gatorade at an additional cost of \$.50
- 20 oz. Water at an additional cost of \$.75
- A three-compartment containerized lunch that will include a sandwich (i.e. pepperoni and cheese croissant, chicken salad, ham and cheese wrap, etc.) and a fruit, vegetable and baked snack with a milk at the same cost of a lunch
- Containerized Chef Salad with the option of two 4oz. sides and a milk for the cost of a lunch
- Containerized Italian Salad with the option of two 4oz. sides and a milk for the cost of a lunch

The NutraKids system has the option of placing restriction on a student's account at a parent's request (i.e. – NO EXTRA'S, LUNCH AND BREAKFAST ONLY, FOOD ALERGIES, ETC.). Each Ohio school district is governed by a five-member board of education which is charged with hiring and overseeing the district superintendent and treasurer, including the annual budget and official district policies. Members also are responsible for determining when a tax issue should be presented to voters. The term is four years.

Mary Kay Martin

Her key issues are:

- 1. Academic Excellence With the help of all concerned stakeholders, the Licking Valley School District needs to continue striving towards achieving academic excellence for all its students.
- 2. **Fiscal Responsibility** The Licking Valley School District needs to continue to be good stewards of the communities money and to continue to press the state on improving the school funding formula.
- 3. **Facilities** Licking Valley is fortunate to have three state-of-the-art facilities in close proximity. These building are the focal point of the community and need to be accessible and inviting to the general public.

Lydia has been a Board member from 2003-2007 and served as Board President 2006-2007. She is a member of the Licking Valley Strategic Planning Committee and the Licking Valley Finance Task Force.

Her Three Key issues are: Continued improvement to the District Report Card, continued fiscal responsibility; and continued support of our Strategic Plan and Goals.

As an incumbent Lydia has helped guide the district through updates and renovations to both the high school and middle school, as well as the completion of Licking Valley's new primary/intermediate elementary school without asking for new tax dollars.

Licking Valley Primary/Intermediate School Student Drop Off Procedures

General Traffic and Parking Information

**Please remember that school buses always have the right of way.

**Please watch for students walking in the crosswalk.

**The right side of the facility is L.V. Intermediate School.

**The left side of the facility is L.V. Primary School.

**The incoming *left turn lane* & *outer loop* are only for <u>buses</u>.

After morning drop off and afternoon pickup gates will be closed to the loop as we will be using the blacktop area as part of our playground during the day.

Morning Student Drop Off Procedures

<u>ALL</u> student drop offs in the morning must be at the entrance of the *Primary Building* (*left side of the building*). Parents are encouraged to do curb-side drop off. There will be a staff member on duty to supervise students coming into the building.

Students who attend the Intermediate Building will simply pass through the interior common hallway to their building.

Buses will begin unloading in the back of the building at 8:30. If you must bring your child to school please make sure they arrive before 8:40 to keep from being marked tardy. *Students arriving after 8:40 must be signed in by the person dropping them off.* After 5 unexcused tardies a recess detention will be issued.

These procedures will help ensure student safety and smoother traffic flow in and out of the facility.

**Although we always welcome our parents with questions or concerns, if you need to speak with a teacher, please make an appointment to do so in advance. <u>All teachers have hallway or bus duties every morning at 8:30 to supervise students.</u> They must report to their duty on time.



Licking Valley Primary/Intermediate School Student Pick Up Procedures

Afternoon Student Pick Up Procedures

Please park and come in the Cafeteria Entrance to sign out your child. If you have a student in both buildings, you can park in either parking lot and enter the Cafeteria Entrance. You will be able to pass from one cafeteria to the other to sign out all of your children.

Student sign out will be from 3:00 – 3:15 in the cafeteria. After you sign out your student you will wait in the cafeteria area and students will be called to come to you. **Students will not be called to be dismissed until** <u>after</u> 3:15 announcements unless you have an appointment.

It is critical that you make pick up arrangements by either sending a note to school with your child or by calling the office no later than 3:00.

If you plan to pick up your child every day you can make those arrangements with the secretary but will still need to come in to sign your child out each day. *Students will not be permitted to leave the building to meet you outside.*

Any student pick ups for appointments earlier than 3:00 should be done in the office.

Be prepared to show a photo ID. If we do not know or recognize you, we *will* ask you to show ID. Please remember to remind anyone else picking up your child of this policy.

Thank you in advance for following these procedures. The safety of your child is a top priority!

The Licking Valley Schools' family came together on Thursday, October 18th to accomplish a mission that has been three years in the planning: moving into our beautiful new elementary facility. The effort was one of which everyone in the Valley can be proud. Staffulty members from every building in the district and many students began at 7 am moving the contents of Madison, Perry and Toboso into the new primary and intermediate buildings. It was a monumental and completely daunting task at the beginning of the day, but with the teamwork, camaraderie, persistence and humor that often only close friends and family can muster in the midst of such hard work, LV accomplished its mission: teachers will be teaching and students will be learning in our new, state-ofthe-art facility on Monday, October 22nd. A gigantic "THANK YOU" to the incredible staffulty and students of LV for the blood, sweat and tears they contributed to this Herculean effort! We are LV!

Disposal of Contents in LV's Existing Elementary Buildings

Many of our staffulty and community members are interested in the disposal of the items in our four existing elementary buildings once the district no longer occupies those facilities. First, it must be explained that because the new facility was built through the Ohio School Facilities Commission (OSFC), the district is not permitted to take any existing furniture to the new building; all of the furnishings for the new facility must be brand new. That means that all of the student and staff desks, tables, chairs, file cabinets, etc. in each building must be left behind.

The Licking Valley Board of Education developed a plan for the disposal of these items. First, the board directed district administrators to identify in each building all items of historical and sentimental value, and to remove those items to storage. The district will maintain possession of all historic and sentimental items such as the score board at Perry, the drums from each building, various pictures, etc. Second, the middle school and high school principals and the leaders of our parent groups and booster organizations were given the opportunity to walk through each building and claim any items for which they had a use. Those organizations will receive those items. Third, we had an offer from one of the new owners of one of the buildings to buy the remaining contents in his building. The board decided that it would only be fair that if we would entertain such an offer from one of the new owners, all of the new owners should have the same opportunity. Therefore, each of the owners were permitted to walk though their building and identify items they would like to purchase directly from the district. Fourth, anything remaining after the owners make their purchases will be slated for auction. Our goal is to have the auction of all remaining items in either November or early December of this year.
